### COOPERATION WITH G. LECLERC TRANSPORT AG

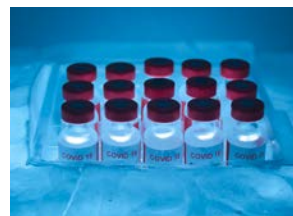
From January 2023, we will be offering you even more security and quality thanks to actively temperature-controlled parcel transport with our partner G. Leclerc Transport AG.

G. Leclerc Transport AG has a Swissmedic operating license and employees who are specially trained in handling pharmaceutical products. The handling rooms guarantee perfect and reliable handling in the temperature ranges of +15°C to +25°C and +2°C to +8°C.

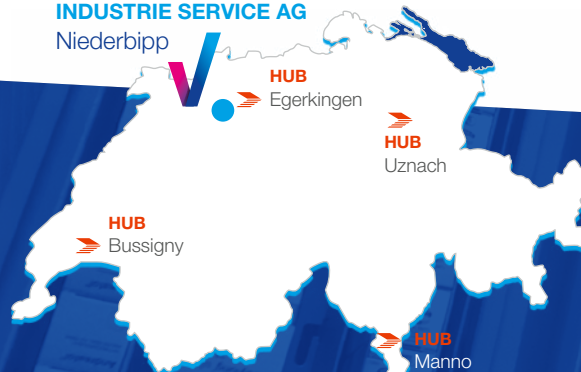
Specially developed vehicles with two chambers for simultaneous transport of refrigerated and ambient products are used for temperature-controlled deliveries of your parcel shipments. The delivery is made in Dispoboxes without any cooling elements. The capacity of the container is therefore higher, while the tare weight is lower. Your customers will appreciate this solution.



## Health Courier

Products are distributed throughout Switzerland via one central and three regional distribution centers. The central distribution center is located in Egerkingen very close to our site in Niederbipp. Most of German-speaking Switzerland is covered from Egerkingen, with the exception of eastern Switzerland and the Engadin. The three other sub-hubs are located in Uznach for coverage of eastern Switzerland and the Engadin, as well as Bussigny for the region of western Switzerland and Manno for the Ticino. Thanks to these locations, efficient and timely distribution of products can be ensured.

## Telematics Infrastructure

### «CARGOFLEET» TELEMATICS SYSTEM

- Real-time temperature monitoring, GPS and door opening control
- Track & Trace with electronic signature
- Personalized driver devices (tablets).  
All drivers have a tablet with SIM card.  
The orders are processed on it as follows:
  - The delivery confirmations are signed paperless directly on the tablet
  - For internal communication, documents and/or messages can be sent electronically directly to the tablet (e.g. delivery receipts, directions, etc.)



## Audited Pharma-Transport

Parcel shipments are delivered throughout Switzerland with a high level of quality and stability. Reliable delivery is ensured by trained personnel, also in the sense of high continuity of the employees deployed. As a rule, delivery takes place by 12:00 noon the next day and is confirmed with an electronic signature from the recipient.

Exceptions to the delivery times are the following places which are delivered the next day until 16:00:

- Cooled vehicle fleet from 3,5t – 40t with over 200 vehicles
- Mono-Therm & Bi-Therm vehicles
  - For actively guided transports, ambient 15–25°C and cool 2–8°C
- Real-time temperature monitoring
  - GPS and door opening control



## Customer Portal

- Voigt transmits the shipment data electronically to G. Leclerc Transport AG
- G. Leclerc Transport AG thus has an order entry system at its disposal by interface
- Shipment status (Track & Trace)
  - Discharge scan at the central hub
  - Outgoing scan at the central hub
  - Incoming scan at the distribution platform
  - Loading scan on delivery vehicles
  - Delivery scan at the recipient
- When the parcels are delivered, the recipient only has to confirm receipt of the delivery with his signature on the driver's tablet
- The delivery message is visible in the customer portal 30 minutes after delivery, the delivery bill no later than 2 hours after delivery.
- Voigt customers receive a URL link for shipment tracking
